REPOSITORY ROUTE

If you published in a subscription journal, you can deposit your author accepted manuscript (AAM) in eScholarship.



What routes can I take to make my research article open access?

JOURNAL ROUTE

If you want to publish open access, you can make the version of record (**VOR**) freely available on the journal's website.

Even if you cannot publish your VOR open access, you can still make your AAM freely available.

Many subscription and open access journals charge a fee (i.e., APC) to make your **VOR** freely available. Does my journal let me publish open access without charging a fee?

Is my publication fee covered by a UC Open Access Agreement? YES

Am I able to use funds from other sources to pay for open access?

Some open access journals have no publication fees so your VOR can be freely available after acceptance.

Some UC authors can get discounts, and funds may be available from your grants, department, or campus library.

Make sure you have assigned a <u>Creative</u> <u>Commons</u> license to your article.


Terms vary, but under most open access agreements, UC will pay for all or part of your publication fees.

UC OPEN ACCESS POLICIES:

The University of California has adopted open access policies ensuring that all research articles by UC staff, faculty, and students can be made freely available.

Depositing your author accepted manuscript (AAM) in eScholarship or making your version of record (VOR) open access on the journal's website complies with UC open access policies.

KEY TERMS:

Open Access (OA):

Research articles and other scholarly works made freely available to readers online and often with licensing terms that allow sharing and re-use. OA articles are peer-reviewed just like subscription articles but publication costs are supported through different business models.

eScholarship:

Open access publishing platform and <u>institutional</u> <u>repository</u> of the University of California, managed by the California Digital Library.

Author Accepted Manuscript (AAM):

The final, peer-reviewed version of an article before formatting by the publisher, usually in an original document file format like Microsoft Word.

Version of Record (VOR):

The final published version of an article that is available on the journal's website.

Article Processing Charge (APC):

A fee charged by some publishers to make an article open access.

UC Open Access Agreement:

A contract with a publisher to re-purpose subscription money in support of open access publishing. Terms vary, but under most agreements, UC authors receive a discounted APC, an automatic \$1,000 library payment, and full payment by the library if authors lack other sources of funding. Check the Office of Scholarly Communication website to see if your journal is covered by a UC Open Access Agreement.

Creative Commons (CC):

Creative Commons licenses enable authors to retain copyrights and decide how their work is used. CC BY, which is the open access license strongly recommended by the UC Academic Senate, allows anyone to distribute, remix, adapt, and build upon the material in any medium or format, so long as attribution is given to the author.
